THE LIBRARY AND ITS CONTENTS ARE OWNED BY THE WILTON LIBRARY ASSOCIATION, INC., WHICH IS GOVERNED BY A BOARD OF TRUSTEES OF 21 MEMBERS. EIGHTEEN OF THE TRUSTEES ARE ELECTED DIRECTLY BY THE MEMBERS OF THE ASSOCIATION AND SIX ARE APPOINTED BY THE BOARD OF SELECTMEN PRIOR TO THEIR ELECTION BY ASSOCIATION MEMBERS.

SINCE 1919, THE LIBRARY HAS RECEIVED PARTIAL FUNDING FROM THE TOWN. CURRENTLY APPROXIMATELY 75% OF THE ANNUAL BUDGET IS FUNDED BY AN APPROPRIATION FROM THE TOWN'S GENERAL FUND. THE BOARD CARRIES OUT AN ANNUAL APPEAL CAMPAIGN FOR THE PURCHASE OF ALL LIBRARY COLLECTION MATERIALS. THE REMAINDER OF OPERATING COSTS AND SOME MAJOR CAPITAL
