IN THE SAME TIME PERIOD, INDIVIDUAL TRUSTEES WILL GIVE TO THE PRESIDENT ANY SUGGESTIONS FOR THE DIRECTOR'S AREAS OF FOCUS FOR THE COMING YEAR.

IN APRIL, THE PRESIDENT WILL MEET WITH THE DIRECTOR CONCERNING THE AREAS OF FOCUS FOR THE CURRENT YEAR AND TO DETERMINE THOSE FOR THE FOLLOWING YEAR. FOCUS AREAS SUGGESTED BY INDIVIDUAL TRUSTEES WILL BE CONSIDERED BUT NOT NECESSARILY INCLUDED IN THE DIRECTOR'S FINAL LIST.

PRIOR TO THE MAY EXECUTIVE COMMITTEE MEETING, THE MEMBERS WILL MEET IN EXECUTIVE SESSION TO RECEIVE THE REPORT FROM THE CHAIRMAN OF THE HR COMMITTEE. THE REPORT WILL INCLUDE A SUMMARY OF THE SURVEY RESULTS, A SUMMARY OF THE DIRECTOR'S ACHIEVEMENT IN THE FOCUS AREAS, AND A RECOMMENDATION ON THE DIRECTOR'S COMPENSATION PACKAGE. THE EXECUTIVE COMMITTEE WILL THEN DETERMINE THE COMPENSATION PACKAGE TO BE PROPOSED TO THE BOARD.

AT THE MAY BOARD MEETING, IN AN EXECUTIVE SESSION OF THE FULL BOARD, THE PRESIDENT WILL PRESENT THE EXECUTIVE COMMITTEE RECOMMENDATION FOR THE DIRECTOR'S COMPENSATION PACKAGE. FOLLOWING DISCUSSION IN EXECUTIVE SESSION, THE BOARD WILL VOTE ON THE PACKAGE IN OPEN SESSION, WITH THE RESULTS OF THE
