THE LIBRARY AND ITS CONTENTS ARE OWNED BY WILTON LIBRARY ASSOCIATION, INC., WHICH IS GOVERNED BY A BOARD OF TRUSTEES OF 20-24 MEMBERS. APPROXIMATELY THREE QUARTERS OF THE TRUSTEES ARE ELECTED DIRECTLY BY THE MEMBERS OF THE ASSOCIATION AND UP TO ONE QUARTER ARE NOMINATED BY THE BOARD OF SELECTMEN PRIOR TO THEIR ELECTION BY ASSOCIATION MEMBERS.

SINCE 1919, THE LIBRARY HAS RECEIVED PARTIAL FUNDING FROM THE TOWN. CURRENTLY APPROXIMATELY 75% OF THE ANNUAL BUDGET IS FUNDED BY AN APPROPRIATION FROM THE TOWN'S GENERAL FUND. THE BOARD CARRIES OUT AN ANNUAL APPEAL CAMPAIGN FOR THE PURCHASE OF ALL LIBRARY COLLECTION
