TRUSTEES OF 20-24 MEMBERS. APPROXIMATELY THREE QUARTERS OF THE TRUSTEES
ARE ELECTED DIRECTLY BY THE MEMBERS OF THE ASSOCIATION AND UP TO ONE
QUARTER ARE NOMINATED BY THE BOARD OF SELECTMEN PRIOR TO THEIR ELECTION
BY ASSOCIATION MEMBERS.

SINCE 1919, THE LIBRARY HAS RECEIVED PARTIAL FUNDING FROM THE TOWN.
